

Testimony: Budget & Taxation Committee

The Regional Manufacturing Institute is a 501 C manufacturing stakeholder organization that promotes Maryland manufacturing and opportunities for people to move from poverty to prosperity through jobs in manufacturing.

I am here today to draw attention to some issues for consideration regarding legislation SB181 to create special manufacturing zones to attract heavy manufacturing companies to Maryland by offering incentives to corporations and workers.

SB181 draws attention to the need to expand manufacturing in Maryland by recruiting new companies to the state. Who can argue with that? The bill offers incentives to new companies and their workers, who move to Maryland.

A major unintended outcome will be that Maryland companies will lose workers who would seek positions with companies that qualify for 10 years of no income tax for workers. This would be a serious blow to smaller and medium sized companies that in some areas would put companies out of business. Engineers, machinists, line workers, technicians working in manufacturing would jump at the chance to work for a company and not pay state taxes for 10 years. Maryland has a serious shortage of workers and this would make it worse for existing companies. Companies who employ machinists would be hard hit if the new companies hire machinists.

I encourage policy-makers to address this problem. For existing Maryland manufacturing companies I offer these ideas to avoid an exodus of workers and to really make Maryland Manufacturing Strong across the state.

- 1) Mount an aggressive campaign to support existing companies when they add "new jobs" to Maryland's manufacturing base by attracting out of state jobs. Provide incentives for companies located in Maryland who:
  - a. have divisions / operations in other states, to move these units to Maryland (Textron, Northrop Grumman and Thorlabs are in the process of moving divisions to Maryland right now.) and/or;
  - b. purchase an out of state company and move that company to Maryland.
- 2) "Make in Maryland, What We Invent in Maryland" So much of the state support of R&D and innovation is lost when the inventions is made elsewhere. We should require companies doing R&D to develop a business plan to manufacture the end product in Maryland. This would create a big impact for creating new manufacturing in Maryland. Provide incentive and support from Commerce.



- 3) Provide Manufacturing companies in Maryland, no cost training based on some criteria like 50 hours a year for each full time permanent worker. Create a manufacturing leadership academy to help companies learn from the best visionaries, how to join the 4<sup>th</sup> Industrial Revolution of technology driven SMART manufacturing.
- 4) For new companies coming to Maryland, require them to use Maryland companies as vendors and suppliers (spread the benefit).
- 5) A major concern of manufacturers is how to pay for college tuition for their children. Offer to existing companies, free tuition and preferential treatment to state colleges and universities to workers, spouses and children of workers.
- 6) For existing companies create a worker investment program to help companies attract talent. Recruit banks to loan money to manufacturers for the purpose of recruiting talent. Manufacturers would offer to pay down student loans at a rate of 20% a year. This is a great tool for attracting talent from around the nation.
- 7) Reduce employer contributions or reduce employee tax as a way to accelerate job growth for existing companies.
- 8) State drug rehab centers with manufacturing training. Take potential employees with addiction problems and train them for manufacturing. Centers should be in high crime areas with busing to available manufacturers.

These ideas may spur other more creative thinking that results in amendments to SB 181 to ensure that existing companies are not hurt and provisions to increase job growth in existing companies.
